

<p>No Trespassing</p>		<p>No Trespassing By Order of the United States Department of Energy Whoever willfully violates these regulations shall, upon conviction, be punishable by a fine of not more than \$5,000. Whoever willfully violates these regulations with respect to any facility, installation, or real property enclosed by a fence, wall floor, roof, or other structure barrier, shall be guilty of a misdemeanor and, upon conviction, shall be punished by a fine not to exceed \$100,000 or imprisonment for not more than 1 year, or both. (Title 42, United States Code section 2278(a); Title 18, United States Code section 3571). By authority of section 229 of the Atomic Energy Act of 1954, as amended (Title 42, United States Code section 2278(a)). The unauthorized entry upon any facility, installation, or real property subject to the jurisdiction, administration, or in the custody of the Department of Energy, which has been designated as subject to the provisions contained in the Title 10 Code of Federal regulation, Part 860, is prohibited. The unauthorized carrying, transporting, or otherwise introducing or causing to be introduced, any dangerous weapon, explosive, or other dangerous instrument or material likely to produce substantial injury or damage to persons or property, into or upon such facility, installation, or real property is likewise prohibited.
