

Los Alamos National Laboratory Impacts and Investments in Santa Fe County

Santa Fe County is home to 1,845 LANL employees and contractors. As of February 2013, \$177,650,934 in annual base salaries was being paid to LANL employees (excluding contractors and craft employees) in Santa Fe County.

In FY12, LANL purchased \$10,391,916 in products and services from Santa Fe County businesses.

Santa Fe is one of seven northern New Mexico counties identified in the Lab's maintenance and operations contract with NNSA that is targeted for education, economic development, and charitable giving programs through the LANS, LLC Community Commitment Plan.

Education

The Laboratory's goal in education is to enhance regional Science Technology, Engineering, and Mathematics (STEM) education and enrichment initiatives through Workforce Development, Student Internships, Teacher and Faculty Professional Development, and Public Understanding of Science.

Los Alamos Employees' Scholarship Fund: Santa Fe County

The 2012 Los Alamos Employees' Scholarship Fund Silver recipients are Emily Talbot of Santa Fe Preparatory School and Elena Vigil of St. Michael's High School. The total amount of the scholarships is \$20,000. Additionally, 27 students from the Academy for Technology and the Classics, Desert Academy Monte Del Sol Charter School, New Mexico School for the Arts, New Mexico School for the Deaf, Pojoaque Valley High School, Santa Fe High School, Santa Fe Preparatory School, and Returning College/Returning Student participants were awarded a total of \$108,000 in academic scholarships.

Bradbury Science Museum: Science education activities conducted by our Museum reached 2,067 Santa Fe County students in 2011. 339 students visited the Museum, and our Science on Wheels educators reached 1,728 students at their schools.

Accelerate Technical Job Training Program: A new regional technical training and job placement workforce development program to prepare people of all ages and educational backgrounds for enhanced employment opportunities. Participating colleges include: Luna Community College, New Mexico Highlands University, Northern New Mexico College, Santa Fe Community College, University of New Mexico-Los Alamos, and University of New Mexico-Taos. The first students enrolled in this program will graduate in 2013.

Northern New Mexico Inquiry Science Initiative: A regional program to improve K-6 student academic achievement in science, math and literacy and to meet or exceed state requirements. This program has benefited seven school districts, 28 schools, and more than 8,500 students.

Santa Fe Community College: LANS invests \$100,000 annually to support the College's Advanced Technologies program. The program has concentrations in Biofuels, Facilities Technology, Green Building, Solar Energy, and Water Conservation.

LANL Laces: This is a year-round Laboratory employee-giving program designed to purchase shoes for children who need them. Elementary school students from Pojoaque and Santa Fe received 52 pairs of shoes in 2012 through this program.

School Supply Drive/Back Pack Challenge: In 2012, Lab employees filled 648 back packs with school supplies for students across northern New Mexico to help prepare them for the school year. Organizations that partnered with LANL to help students in Santa Fe County included: The Boys and Girls Clubs of Santa Cruz and Chimayo, Pojoaque Valley Schools, Holy Cross Catholic School, and Wings for Hope.

Economic Development

The Laboratory has been involved with the Santa Fe business community as a member and strategic partner with the Santa Fe Chamber of Commerce (a member since 1990), Santa Fe Business Incubator, Northern NM Chapter of NM Technology Council, Regional Development Corporation, and High Desert Discovery District.

Los Alamos Connect is the principal economic development investment of Los Alamos National Security, LLC and Los Alamos National Laboratory. Its collection of coaching, networking, research, technical assistance, and investment activities are designed help businesses reach the next level of success and create an entrepreneurial culture in northern New Mexico.
