#### PROGRAMMATIC ENHANCEMENTS TO THE STANDARDS

#### WELDING INSPECTOR TRAINING/CERTIFICATION

Because weld inspection is required by all the governing codes through ESM Chapter 13 and is also appropriate for some non-code, R&D work, MST Division is sponsoring an AWS Welding Inspector Training/Certification seminar September 11-17, 2005 (Sun 1 PM through Fri 5PM). The seminar will be comprised of four parts: the D1.1 Code Clinic, the Code Clinic for API-1104, the Welding Inspection Technology Seminar, and the Visual Inspection Workshop.

The approximate cost is \$1500/participant. A program code will be required with your application and will be non-refundable.

AWS will provide the Certification Manual for Welding Inspectors (CM: 2000) as pre-course study material for each student. CM: 2000 will be shipped prior to the seminar. AWS will conduct the Certified Welding Educator (CWI) examination here on Saturday following the CWI seminar. The CWI examination will be scheduled through the Certification Department; Exam applications must be received at least seven weeks prior to the 9/18 exam date. Applications submitted after this date, are subject to the Certification Department Fast Track Processing Fee of \$250. Each seminar participant will receive a one-year membership in AWS at no additional charge. AWS will issue certificates of participation to all participants.
