

## **SUMMARY ANNUAL REPORT FOR TRIAD HEALTH AND WELFARE PLAN FOR EMPLOYEES**

This is a summary of the annual report of the Triad Health and Welfare Plan for Employees, (Employer Identification Number 82-3291283, Plan Number 501), for the plan year 01/01/2022 through 12/31/2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Triad National Security, LLC has committed itself to pay certain temporary disability, and all health, dental, vision and severance claims incurred under the terms of the plan.

### **Insurance Information**

The plan has insurance contracts with ARAG Insurance Company and Metropolitan Life Insurance Company to pay certain temporary disability and all life insurance, legal, long-term disability, and accidental death and dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending plan year ending 12/31/2022 were \$14,337,927.
