

COMPANY QUESTIONNAIRE FOR SBIR/STTR REQUEST TO LOS ALAMOS NATIONAL LABORATORY

This questionnaire is to gather necessary information Triad National Security, LLC (Triad) (on behalf of Los Alamos National Laboratory (LANL)) requires to consider participation as a sub-contractor or research institution on a proposal. Additional information may be requested based on the capabilities, work, or proposal submission requested. Triad/LANL reserves the right not to perform technical work for, or in collaboration with, a company based upon information that may not have been available to Triad/LANL at the time Letters of Intent or statement of capabilities were submitted to the federal sponsor.

Recommendations:

- Contact the potential LANL Principal Investigator (PI) directly about a proposal to determine whether they have the needed capabilities, resources, expertise and availability to participate if awarded.
- The SBIR/STTR coordinator may be approached to identify a potential PI if the company is aware of Triad/LANL capabilities but does not know of an appropriate LANL PI to approach

Considerations when Approaching Triad/LANL:

- A company must request Triad involvement and provide this company questionnaire to the SBIR/STTR Coordinator at least **3 weeks prior** to the proposal submission deadline in order for:
 - Adequate time to review, approve and generate documentation for the request
 - For a company to receive permission to include any official documentation regarding Triad/LANL
- Completion of the following company questionnaire guides the creation of the SOW, budget and any other documentation to include Triad/LANL in a proposal
 - The clearer and more complete the company questionnaire is the faster reviews can be conducted
- Once all documentation and approvals have been received, the SBIR/STTR Coordinator will generate a Statement of Capabilities Package which will contain the necessary information to include Triad in the proposal
 - Only documentation provided by the SBIR/STTR Coordinator may be included within a proposal
- If a proposal is awarded that includes Triad/LANL and was not reviewed and approved, there is no guarantee that Triad will conduct the requested work
- If a proposal is awarded, the company must enter into an agreement with Triad before work can begin. Per DOE requirements, Triad cannot enter into another institution's agreement, so a company will need to enter into either a Strategic Partnership Project with a Non-Federal Entity (SPP-NFE) agreement or Cooperative Research and Development Agreement (CRADA) in order for LANL staff to receive funding and conduct work
- Foreign aspects of the company and/or foreign involvement in the project will require additional reviews
- LANL's involvement is dependent on:
 - Whether the proposal states Federally Funded Research and Development Center (FFRDC) or national laboratories are eligible to participate
 - Whether requested Triad/LANL capabilities and work are unique and do not compete with services available in the private sector
 - LANL Staff have availability for the requested work
- As a FFRDC, Triad cannot provide any preferential treatment to individual companies or organizations
 - Therefore, Triad cannot provide letters of support as part of proposal submissions. Only a statement of capabilities can be provided regarding services that are available for any eligible entity
